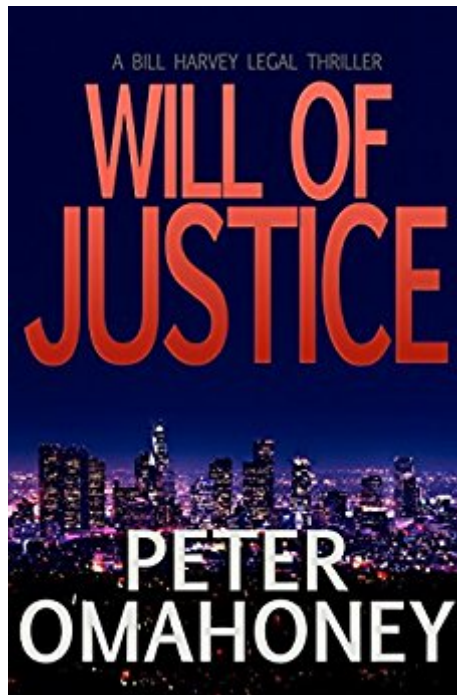

This book would have been easier to read if the dialogue was a little less stilted. The story was good, but getting past the unrealistic conversations was difficult. And the use of non-American terms was also strange (lounge vs. living room, jumper vs. sweater , corporation vs. association, etc.); wasn't this edited by someone from the US?

The story was a fun 'who done it'. The writing was somewhat too exposing. The reader could imply the meaning instead of the elementary explanations, but getting beyond that, the character building and human exposures were meaningful to keep high interest in the outcome.

I enjoyed this book. I have a hard time finding good, clean legal stories, so I was happy to see very little foul language in this one. Still, a novella doesn't take the time to develop the plot like a regular novel.
