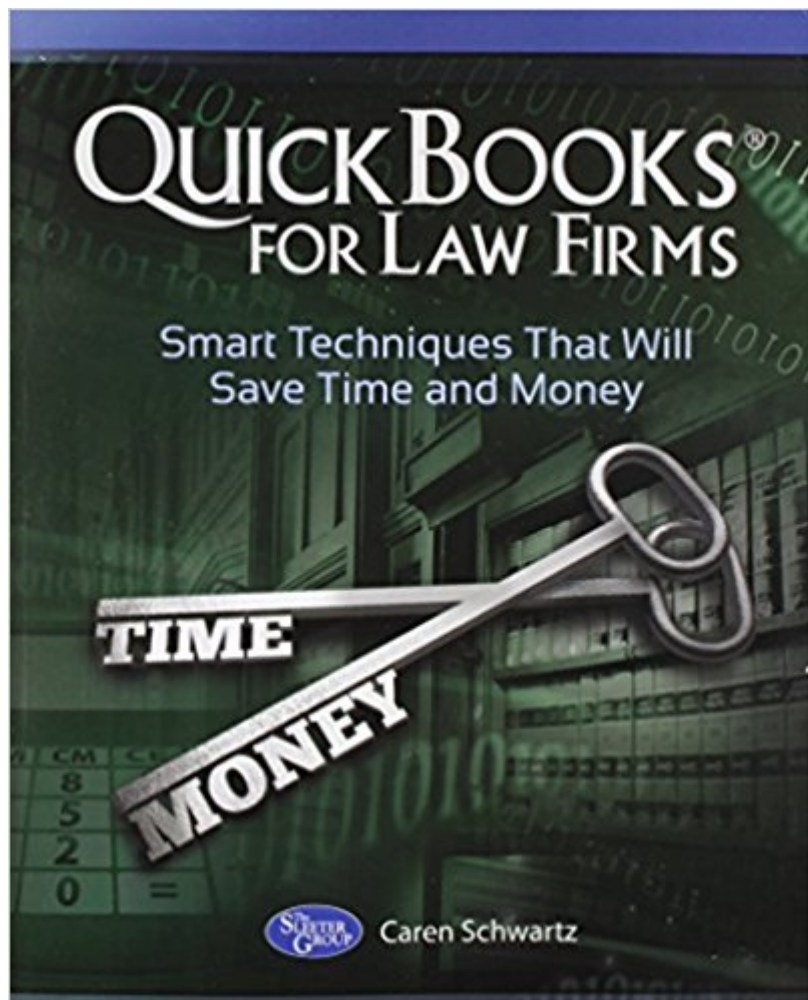

I did find some useful tips in this book but I expected a lot more depth and detail. The author spends a lot of time on basic Quickbook functions which a regular user already knows. I bought this because I thought they were going to provide a lot more information specific to law firm accounting. I

skimmed through more than half the book looking for the meat. The book is easy to read and clear. On my iPad it was very handy that I could tap on the illustrations and then expand them to read them easily.

If you want to speed up your bookkeeping time and set your accounts and procedures properly get this book. Billing is down to less than 2 hours a month for over forty invoices each time and retainer and trust accounting procedures are great.

A very well written book and easy to follow and understand. Caren also makes sure that we understand the legal terminology and how it applies in QuickBooks.
