

Her research is in the areas of juvenile justice, women and law, and criminal justice policy. She is the co-author (with Dean J. Champion and Peter J. Benekos) of *The Juvenile Justice System: Delinquency, Processing, and the Law*, 7th (Pearson), co-author (with Peter J. Benekos) of *Crime Control, Politics & Policy*, 2nd (Anderson), co-editor (with Peter J. Benekos) of *Controversies in Juvenile Justice and Delinquency*, 2nd edition, (LexisNexis/ Anderson); and co-editor (with Joycelyn M. Pollock) of *Women, Law & Social Control*, edition (Allyn and Bacon). She is the past-president of the Academy
