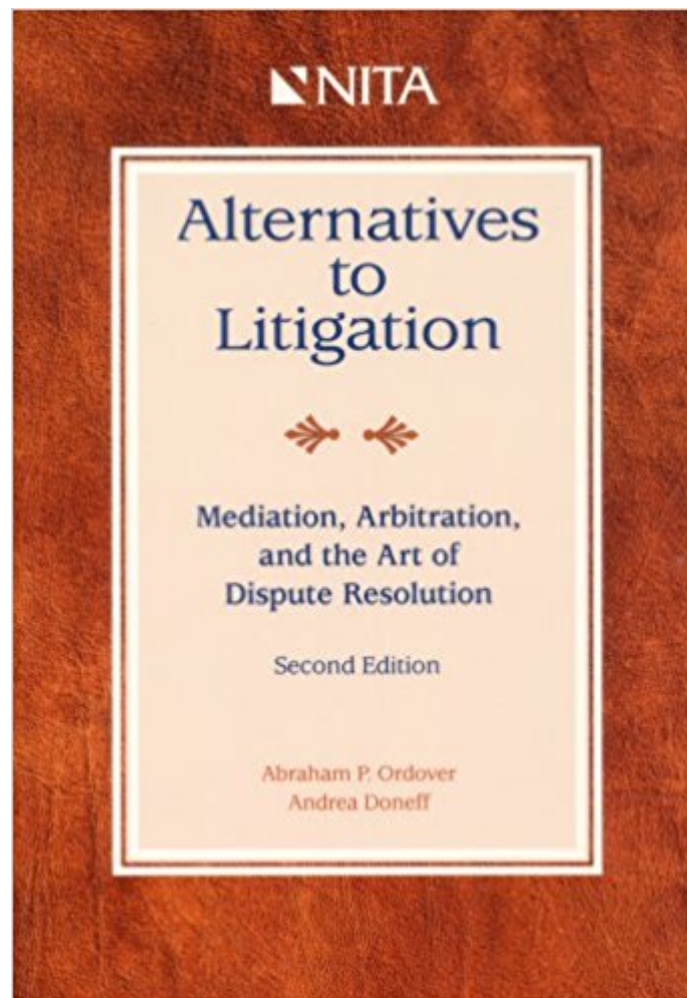

Nearly a decade later, *Alternatives to Litigation, Second Edition*, has been revised and expanded to reflect the growing interest⁹⁷;and in some states mandatory use⁹⁷;of alternative dispute resolution. Appendices include an agreement to mediate, an opening statement checklist, a contract for arbitration, and abbreviated clauses for standard business agreements.
