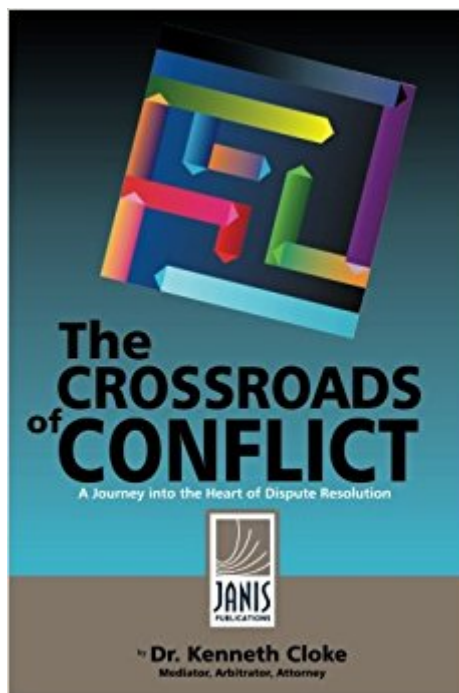

Kenneth Cloke is Director of the Center for Dispute Resolution in Santa Monica, California, and President and co-founder of Mediators Beyond Borders in Pittsburg, Pennsylvania. He is the author or co-author of ten books, a mediator, arbitrator, attorney, coach, consultant, trainer and internationally recognized speaker.

The material is mostly relevant but towards the end of the book I had difficulty keeping interest. I felt that the book was willing to incorporate all religious views but Christian. It is required for my degree and there are many things mentioned in the book that I did take note of. Overall, I am maybe too literal and appreciate more direct skill implementation than theory.

I got way more than I expected from reading Kenneth Cloke's book. I feel he has expanded my perspective on conflict into the spiritual dimension and I intend to use everything he teaches in my work as a mediator and a person of peace.

A lot of good ideas, held back by a dated, modernist view of how to analyze and understand the world. It reads like it was published in 1976, not 2006. Some dubious use of fields of study the author doesn't understand well, such as brain science, psychology, physics, and mathematics, without footnotes or even a bibliography. Quotes from writers, poets, philosophers, Freud and Jung, and humanist religious thinkers -- largely white men. The most useful parts of the book were the case studies, especially the one where he described mistakes he made. Skim it and take what you need. Take the really good ideas for how to mediate effectively. Take or leave the rest.

Ken Cloke is a foremost expert when it comes to the art and style mediation and negotiation. This and his other books can lead you through the journey.
