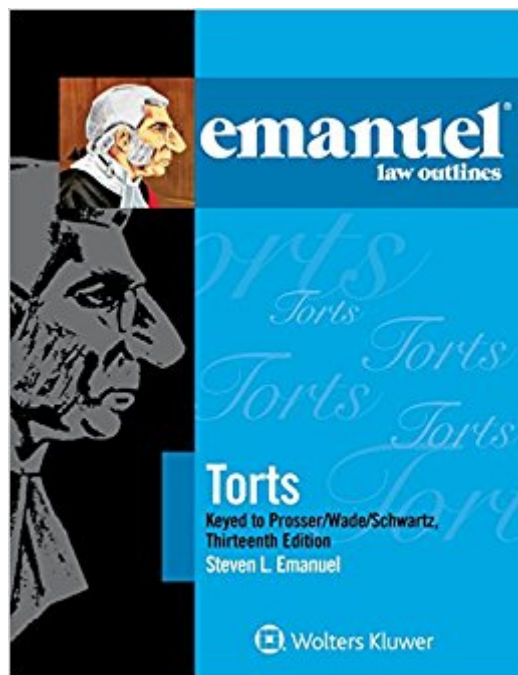

Pretty much a life saver for torts. I am so glad I bought this! I tend to make my own outlines for classes, but this is such a useful supplement to make sure that I have grasped all the relevant information. It also puts all of the examples into perspective- in order of relevance for each element. I highly recommend purchasing this supplement if you have trouble organizing your thoughts or if you simply want a phenomenal outline to study from.

This is obviously a great resource for those whose professors teach "to the book." It also helps to fill in the numerous lacunae in PWS by quoting from the Second and Third Restatements of Torts. I found the "quiz yourself" sections and the short-but-concise capsule summary at the beginning each very useful. For me, this resource was an absolutely necessary resource for exam preparation. A few negatives: It strayed from the book in an unhelpful way by not having a separate section on Apportionment like in PWS. It's not a big section (or big issue), but the discussion of the case under the "Apportionment" section in PWS was subsumed within discussion of another issue in this outline. I don't know why. Also, at times, it tries too hard to fill in the gaps in PWS by going off on tangents. Discussion of the seat belt defense is a good example. It's barely touched on in PWS (at

least in the casebook chapters I covered), but it gets a full-page treatment in the corresponding section of this outline. I know the author is trying to be comprehensive, but it can be distracting when one is trying to find information that matches with the cases or notes in PSW. Nonetheless, this outline is highly recommended.

Limited use. Also, chapter structure doesn't completely match the keyed book, as if someone screwed up on the editing. Felt ripped off, as if a newer edition number was slapped on an older book. Contacted publisher about it, and never got a response.
