

He is currently a professor in and chair of the Department of Criminal Justice at California State University, Long Beach. His area of specialization is the social scientific study of courts and law. This includes research and teaching on the historical development of substantive, procedural, and evidentiary criminal law (including the courtroom acceptability of forensic and social scientific evidence, especially forensic psychological/psychiatric
