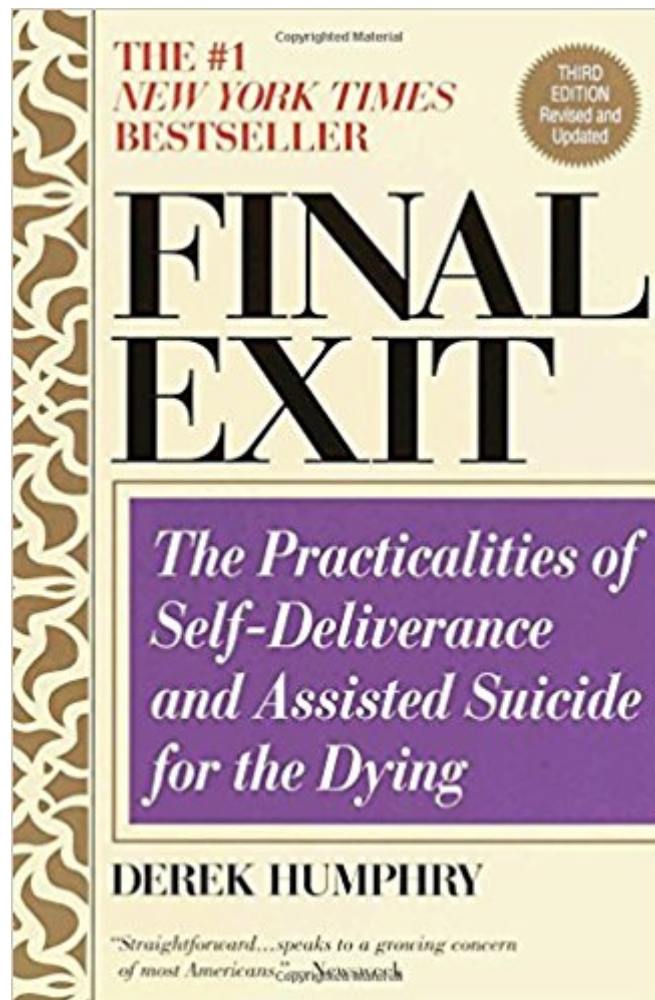

Derek Humphry does an amazing job of explaining the intricacies of self deliverance and euthanasia. It provides a dignified alternative to an otherwise terrible situation and it's great to have an understanding of the different options available. You never know how life is going to turn out and, if you want to be prepared for all situations, I would definitely recommend reading this book. However, I will say that if you are looking for information on how to end your life due to severe mental illness this is not the book for you. Humphry explicitly says this in the beginning and continues to do so throughout the course of the book - which I appreciate. This book is solely for the purpose of aiding those who are terminally ill.

I found this book to be incredibly informative. Watching my parents in the throes of death has made me vow to not do this to my children. Any ideas I had prior to reading this book were dispelled and I'm grateful to know what doesn't work! The book is not for the weak at heart - especially the illustrations but I've already connected with a partner and hope, that when the time comes, I'll have the fortitude to carry through.
