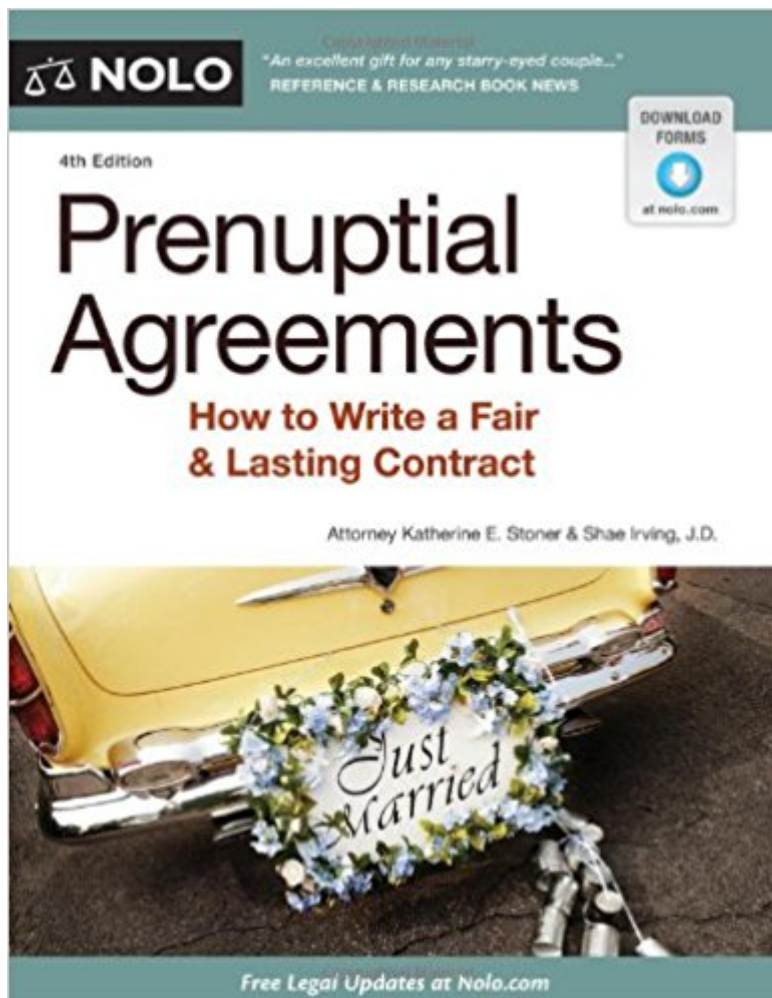

I found this book extremely informative, the worksheets are very helpful in getting started. Doing a prenup can be intimidating too and it helped take some of the fear out of doing a prenup. I realized that doing one is best for both of us. I definitely recommend this book!

This is an excellent reference and guide. Lots of information, more than most will need, but it provides a template, guide and then suggests nearly every contingency one might consider. We found the basic elements that we needed and composed around simpler requirements. The iron

clad lawyer proofing and brass knuckle document strategies mostly work to a lawyer's advantage, not to yours, so we kept the basic subjects to fewer groups of money, property and inheritances defined for separation, divorce or death. This was followed up with a Will and a Living Trust, using the same Nolo books. For firming up new relationships, this a best book to go with, but think in terms of only your needs and not the totality of the book, or you'll be frustrated.

Don't put your head in the sand. Think it out now and work it out now. Divorce is painful enough, fix this NOW. Before you are married. It is good to talk about your concerns and protect each other in life and in death or if there is a need to divorce.
