

This book appears to basically contain information from the authors templates for preparing a private placement memorandum (PPM) for a Rule 505 exception. The actual discussion of "advantages to regulation d, rule 505" runs from page 3-7. Yup, that's right - 4 pages. His other books on 504 and 506 exceptions follow the same format. I was looking for a discussion of why you would pick 505 over one of the other rules, with some real world examples, but apparently that is too much to expect. I would never recommend this book and personally wish I could have my money back.
