

He is the developer of widely used instruments, including the Structured Interview of Reported Symptoms (SIRS), a leading test for the evaluation of malingering.

Dr. Rogers has once again compiled a superb collection of scholarly articles on diverse areas of malingering assessment. I literally have referred to this text dozens of times since I purchased it. It was a major source of information for a paper I recently wrote that concerned, in part, assessment of dissimulation in forensic disability evaluations. I also recently read the chapter, Assessment of Recovered and False Memories, which helped me better understand a complex, challenging case. Rogers' introductory chapters will provide you with a sophisticated understanding of the principles, assessment approaches, and research strategies related to detecting significant exaggeration and

feigning of mental disorders (in addition to similar information on the detection of defensiveness or under-reporting). I highly recommend this essential reference.
